Extend Concession Agreements for 35 years

The Sharjah Ports, Customs and Free Zones Authority (SPCFZA) and Gulftainer, a regional operator of ports and terminals, have agreed to extend their concession agreements for a further 35 years. The extension reinforces their joint commitment to upgrading the UAEss supply chain and logistics sector, particularly through the key trade gateways in the Northern Emirates: the Sharjah Container Terminal (SCT) and Khorfakkan Container Terminal (KCT).

The agreement also includes plans to offer unique value propositions at both SCT and KCT, with the former being renowned as the first container terminal in the Middle East.

Foils an Attempt to Smuggle 10 kg Narcotic Substances

Sharjah Customs inspectors at Port Khalid Customs Centre, foiled an attempt to smuggle 10 Kgs of Narcotics. The Inspectors during a routine inspection on container have successfully identified a suspicious object resembling a bag by using advanced radiation detection technology.

Upon manual examination of the bag, the inspectors discovered 10 rolls each containing a dark, grass-coloured substance, totalling a weight of 10.046 kilograms.

The confiscated narcotic substances were promptly referred to the competent authorities for necessary legal action.

The Sharjah Ports, Customs and Free Zones Authority (SPCFZA) expressed its profound appreciation for the efficiency and capability of the inspection officers and staff at the centre, lauding their high sense of security. It stressed that customs inspectors will spare no effort to bust smugglers and thwart any attempts to bring prohibited materials through the customs ports of the Emirate of Sharjah.

The authority reaffirmed its commitment to mobilising all its resources to curb any form of smuggling, particularly narcotics, and protect the security and safety of society, thereby supporting the national economy and fostering its competitive growth and prosperity.

Took Part in a Workshop on the Enforcement of IP Rights at Borders

Sharjah Customs took part in a workshop addressing enforcement of intellectual property rights at borders. The workshop, organized collaboratively with the Federal Authority for Identity, Citizenship, Customs & Port Security, covered various facets of law enforcement procedures within the UAE, specifically regarding counterfeit materials at border crossings.

Eman Al Salman, Head of Intellectual Property Department at Sharjah Customs, outlined the department's role in trademark registration. She detailed the protocols followed in seizing containers suspected of holding counterfeit goods, the process for the disposal of counterfeit materials, and the strategies employed to educate inspectors on distinguishing between authentic and counterfeit items. She also highlighted initiatives aimed at promoting intellectual property awareness among students at both school and university levels as well as lady's centres.

Abu Dhabi, Dubai, Ras Al Khaimah, Ajman and Fujairah Customs Authorities also participated in the workshop.
