## **Sheikh Khaled Al Qasimi**

Stresses on Improvement of Operations and Simplification of Customs Procedures at the Sharjah Border Terminals

> Sheikh Khaled bin Abdullah bin Sultan Al Qasimi, Chairman of Sharjah Ports, Customs and Free Zones Authority, has stressed the importance of continually boosting the efficiency and readiness of customs centres, terminals and border points at the Emirate's level, calling for ensuring their integration and cohesion.



This can be achieved by improving operations, simplifying procedures and developing customer services in line with the Sharjah government directives aimed at upgrading the services provided by Sharjah terminals, supporting and strengthening the national economy and developing and facilitating the movement of trade and travellers. Sheikh Khaled made these remarks during his meeting with the head and members of the Customs Policies and Procedures Committee at Sharjah Customs, during the committee's second meeting, which has been recently held at the Sharjah Airport International Free Zone.

The meeting was attended by His Excellency Mohammed Mir Abdul Rahman, Director of Seaports and Customs Department at the Sharjah Ports, Customs and Free Zones Authority, His Excellency Saud Salim Al Mazrouei, Director of Hamriyah Free Zone Authority and Sharjah Airport International Free Zone Authority and Mohammed Ibrahim Al Raisi, Director of Terminals and Border Points Affairs, Head of the Committee.

During the meeting, five teams were set up and formed under the umbrella of the committee to carry out several tasks including conducting a study on standardizing work procedures, identifying strengths and weaknesses, and submitting recommendations for development, as well as preparing studies on policies and regulations governing work systems in order to provide more facilitation.

The five teams include a special working group to develop a systematic mechanism for exchanging information, in addition to another team to prepare a manual for customs procedures and measures, while the third team will be tasked with mapping out a plan for smart electronic transformation.

The committee approved the tasks and responsibilities and the membership of the teams, which will feature customs, administrative, financial and technical competencies representing the Sharjah Ports, Customs and Free Zones Authority.

Sheikh Khalid was briefed on the duties of these teams, instructing the committee to ensure that these teams are fully qualified to work permanently in accordance with a well-thought-out strategy.

He stressed the importance of carrying out field tours and visits to customs centres in order to check on the extent to which they meet all evaluation criteria conducted by audit and evaluation teams from local, federal and security departments.

"Customs centres must be fully ready to meet all assessment criteria at all times and must be managed by capable cadres who can professionally manage these centres. All ongoing digital transformation projects should be sustainable, equipped with artificial intelligence techniques and based on innovation and creativity. They must also be easy to use by employees and customers, and shall undergo a periodic assessment to keep pace with the latest developments and changes," Sheikh Khalid said.

For his part, Mohammed Ibrahim AI Raisi reviewed the smart digital transformation plan for customs services and the stages of implementation.

"This plan comes in line with the aspirations of Sharjah Government and the objectives of the Sharjah Digital Office, which aims to adopt best practices and build an advanced digital system in which the government works around the clock to serve the people sustainably, provide integrated government services to all individuals based on simplified mechanisms that save them time and effort", Al Raisi concluded.

Established in 2004, Container Customs Centre is located at the Inland Container Depot in Sharjah's industrial area 18 on Maliha Road. The depot is easily accessible from adjacent roads(Emirates Road and Sheikh Mohammed bin Zayed Road), thus providing advantage for the traders of the nearby industrial & commercial areas and the Sharjah International Airport Free Zone. Customs clearance and inspection are operated by this centre to provide necessary customs service to the customers for containers arriving from the ports of the Emirate of Sharjah and the other Emirates.

Sharjah Customs recently foiled an attempt to bring into the country eight cars sought by the International Criminal Police Organization (INTERPOL).

# **Sharjah Ports:**

Cargo throughput Increase in Q3

> Cargo throughput of the main Sharjah Seaports (Khalid, Hamriyah and Khorfakkan) during the third quarter of 2021 was higher than that of Q2020 3 increased and continued to improve.

Sharjah Ports Exports, Imports, Re-exports and transit for non-oil cargo shipments (including general cargo, dry bulk and liquid bulk) increased by 18.5% from 2,561,407 tons in Q3 2020 to 3,034,898 tons in Q3 2020.

The number of imported and re-exported vehicles through Sharjah Ports has increased by 22.6% in Q3 2021 and totaled 48,879 vehicles from 39,878 in Q3 2020.

Non oil Exports from Sharjah Ports has increased considerably by 133% from 111,575 tons in Q3 2020 to 296,339 in Q3 2021.



# Hamriyah Heavy Cargo Shipment

Hamriyah Port, is one of the most thriving seaports in Sharjah with vessels calling for loading and unloading cargoes. With its multipurpose berths and facilities and with a uniform depth of 14m alongside all berths, the Port is an ideal hub for shipping heavy lift cargo.



MV Hua Yong Long, a heavy load carrier recently called the main Port of Hamriyah to carry a project cargo of six heavy structures being bases for gigantic wind turbines.

The loading of the cargo was done smoothly and professionally as all pre loading measures and precautions were taken by crew of the vessel and the supporting port team on berth to end the operation safely.

Hamriyah is a multipurpose port that handles all kinds of cargoes like project and heavy lift cargoes, traditional break bulk, bagged cargoes, Ro-Ro, bulk grain, bulk industrial cargoes, liquid petroleum and chemical products.

In addition there is an inner harbor of 5 km of quay with a maximum depth of 9 meters along selected berths serving the needs of petroleum products storage and marine industry investors in the Hamriyah Free Zone as well as the offshore support service industry.
